1. ACADEMIC FACULTY

- Role: Teach and mentor students in healthcare-related programs.
- Setting: Universities, colleges, vocational schools, medical education companies.

2. ASSESSMENT AND EVALUATION SPECIALIST

- a.Role: Designs and implements assessment tools to measure the effectiveness of educational programs. Analyze data to improve course offerings and student outcomes.
- Setting: E-learning companies, educational institutions, healthcare organizations, organizations and associations, medical education companies.

3. CONTINUING EDUCATION ACCREDITATION

- Role: Ensures compliance standards are implemented and adhered to for CE activities based on various regulatory needs and integrate quality improvement as needed.
- Setting: Hospital, state medical societies, National accreditation company, independent consultancy, medical communication companies.

4. CLINICAL EDUCATOR

- Role: Develop online educational content and programs for healthcare professionals.
- Setting: E-learning companies, educational institutions, healthcare organizations, organizations and associations, medical education companies.

5. CONTINUING EDUCATION OPERATIONS & CUSTOMER SUPPORT

- Role: Manage CE course data, oversee registrations of classes, track learner history, track revenue and expenses, general reporting

6. CONTINUING EDUCATION PROGRAM MANAGERS

- Role: Provide program management overseeing promotional and continuing healthcare education tasks such as compliance and managing stakeholders.
- Setting: Hospitals, medical schools, professional associations, healthcare organizations, medical education companies.

7. CONTINUING EDUCATION PROVIDER

- Role: Plan, develop, manage, and execute live and online CE programs for healthcare professionals.
- Setting: Hospitals, medical schools, professional associations, healthcare organizations, medical education companies.

8. CONTINUING EDUCATION MEETING PLANNER

- a.Role: planning and management for Annual Meetings, Education Seminars, domestic or abroad. Role responsible for overall meeting management, budgeting, advance planning, onsite planning, and logistics, as well as ongoing communication with internal and external stakeholders.
- Setting: Medical schools, hospitals, consultancy firms, healthcare systems, medical associations.

9. CONTINUING PROFESSIONAL DEVELOPMENT CONSULTANT

- Role: Offer expertise and guidance on continuing education and professional development strategies.
- Setting: Independent consultancy, healthcare consulting firms, medical education companies.

10. GRANT ANALYST

- Role: Approve and process grant funding for educational activities, collate impact reports for insights, create graphical illustrations of KPI measurements.
- Setting: Pharmaceutical firms, biotechnology companies.

11. GRANT WRITER/MANAGER

- Role: Write proposals to secure funding for continuing education programs.
- Setting: Non-profit organizations, educational institutions, research institutions, medical education companies, societies.

12. HEALTHCARE POLICY ANALYST

- Role: Analyze and develop policies related to healthcare education and workforce development.
- Setting: Government agencies, think tanks, policy research organizations.

13. HEALTH COMMUNICATION SPECIALIST

- Role: Design and deliver educational campaigns and materials to improve health literacy to the public.
- Setting: Public health organizations, marketing agencies, healthcare providers.

14. INFORMATION TECHNOLOGY FACILITATOR

- Role: Create and edit audio/visual for enduring materials, provide support for live online education
- Setting: Independent consultancy, healthcare consulting firms, universities, colleges, vocational schools, medical education companies, hospitals, medical schools, professional associations, healthcare organizations.

15. IME MEDICAL AFFAIRS PROFESSIONAL

- Role: Oversee IME Medical strategy and tactical plans, review grants proposals, manage budgets, evaluate activities, analyze outcomes, and present outcomes to internal stakeholders.
- Setting: Pharmaceutical firms, biotechnology companies.

16. MEDICAL ILLUSTRATOR

- Role: Create visual representations of medical information to translate complex technical information into visual representations.
- Setting: Independent consultancy, healthcare consulting firms, universities, colleges, vocational schools, medical education companies, hospitals, medical schools, professional associations, healthcare organizations.

17. MEDICAL LIBRARIAN

- Role: Provide information and resources to support healthcare professionals' continuing education.
- Setting: Medical libraries, academic institutions, hospitals.

18. MEDICAL WRITER/EDITOR

- Role: Writing regulatory documents, clinical study reports, user manuals, and training materials.
- b.Setting: Pharmaceutical firms, medical education companies, medical journals, non-profit organizations, hospitals and healthcare systems, organizations.

19. PROJECT MANAGER

- Role: Oversees special projects related to continuing education, such as developing new programs, partnerships, or initiatives to expand offerings.

20. QUALITY IMPROVEMENT SPECIALIST

- Role: Develop and implement strategies to improve the quality of care provided by healthcare professionals.
